4. Any direct application for concession in fee shall not be entertained by KIPS.



6. MRF will provide 100% free treatment through Sehat Sahulat Card to PP staff on priority basis.
7. MRF will organize free medical camps at PP along with diagnostics services on need basis.
8. The agreement places NO Financial/Legal obligations on either of the parties.
9. This MoU will come into effect on the date of signatures by the Parties and will remain effective for duration of One year.
10. Either Party, upon One-month advance written notice to the other Party, may terminate this MoU at any time.
11. Any modification concerning the MoU may only be made by mutual consent in writing between both parties.


